



CONSENT AND RELEASE FOR BIBBIDI BOBBIDI BOUTIQUE EXPERIENCE

The Disney Store Limited on behalf of itself and its affiliates (“**Disney**”) is very excited to offer your child the opportunity to participate in the Bibbidi Bobbidi Boutique Experience (the “**BBB Experience**”). - (a) the BBB Experience is not available to children under 3 years of age as very young children may be overwhelmed by the results and certain products are not recommended for children under 3 years;
- (b) the BBB Experience is not available to anyone who is obviously unwell (e.g. runny nose, temperature, rash) or has any skin complaint (e.g. eczema, chicken pox, acne, cold sore, open wounds, eye infections, lice and/or other hair/scalp conditions);
- (c) your child must be under constant adult supervision during the makeover and while waiting their turn;
- (d) you hereby confirm that your child does not have any allergies or skin complaints that might be impacted by makeup and voluntarily agree to accept and assume responsibility in connection with your child’s participation in the BBB Experience;
- (e) as set out in paragraph 19 of our Terms and Conditions (agreed to at the time of booking and attached), we do not exclude or limit our liability where not permitted by law, however you are responsible for the active and constant supervision of your child during the BBB Experience and, to the extent permitted by law, release and discharge Disney from all claims or demands in connection with risks associated with the BBB Experience voluntarily assumed by you; and
- (f) as indicated below, you do not object to Disney storing and using copies of your, and your child’s, name and image or your contact details in case we need to contact you.
